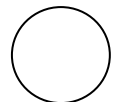


Consignment Agreement

Deco Daze Antiques and Collectibles

“Consignor” and “Deco Daze”

- 1. The “Consignor” is the owner of all goods consigned to “Deco Daze” and has the legal right to enter into this Consignment Agreement.**
- 2. “Deco Daze” retains the right to accept or decline any item for consignment at their sole discretion.**
- 3. “Consignor” must present all items clean, complete and free of defects. If appropriate “Consignor” provides history and provenance of goods.**
- 4. “Consignor” is responsible for contacting “Deco Daze” seven (7) days prior to retrieving their goods. “Consignor” cannot go to shop to retrieve their goods. “Deco Daze” will pick up and deliver goods. A fee of \$50.00 will apply.**
- 5. “Consignor” authorizes “Deco Daze” to price items on their behalf. The “Consignor” may choose to authorize a 10% discount at point of purchase as buyer incentive.***
- 6. “Deco Daze” collects a commission on all goods sold equal to forty percent (40%) of the list price which includes processing and stock fees. 5% additional fee if paid by credit card forty-five percent (45%) including credit card processing.**
- 7. “Deco Daze” does not mail cheques. The “Consignor” will pick up their cheque for items sold within thirty (30) days. After a forty-five (45) day holding period, money is non-refundable.**
- 8. “Deco Daze” is not responsible for loss, theft or damage to “Consignor” goods from any cause whatsoever. Insurance coverage remains the sole responsibility of the “Consignor”.**
- 9. All “Consignor’s” goods are listed, priced and initialed by “Consignor” on the Consignment Agreement.**
